

## DIVORCE CERTIFICATE

We, the Archbishop of Athens, taking into account the agreement of the Law by the order document number 15642 2003 of the public prosecutor of the court of first instance of Athens sent to Us under number 527 and from 23/1/2003 by decision of the ATHENS Court of First Instance, became definitive and irrevocable from 15/4/2008, an official copy of which was deposited in the Archives of Our Holy Archdiocese (number 1760), and thereby the relationship between

CHRISTOS AMYND A KOUROU resident of ATHENS

and of his wife PANAGIOTA

nee of ANASTASIOU NIGIANNI resident of N. SMYRNI S

Marriage, we declare, in accordance with the Statutory Charter of the Church of Greece, and spiritually dissolved between the divorced Marriage, performed IN ATHENS, 4/5/2003 BY VIRTUE OF THE MARRIAGE LICENSE FIRST (A) NO. 380, FIRST (A) OF BOTH

those who are divorced and strangers to each other, no longer having matrimonial connection or relationship, and able, if they wish, to enter in another legal Marriage communion, according to the Canonical provisions of the Eastern Orthodox Church.

Whereas the present Ecclesiastical Divorce Certificate is given by Us to both of the above divorced (one each) as proof.
