In early 2013 I was invited to apply for a Readership/Chair at Goldsmiths College, London. I was appointed at the top of Senior Lecturer and promoted to Reader (Associate Professor) by the Goldsmiths central promotion committee shortly afterwards. For just under 3 years I ran the Centre for The Arts and Learning and I established the Goldsmiths Disability Research Centre with Professor Rob Imrie. I built a new PhD program which had 9 students within 2.5 years. I held a major international conference (London Conference in Critical Thought), and published a collection of works showcasing the Centre members. I returned unexpectedly to Sydney as my mother was suffering a period of ill health. A significant aspect of my work at The Centre for The Arts and Learning related to changing institutional cultures. Under my leadership at Goldsmiths, one the Centre members completed their PhD with my support and one began a PhD. 12 publications from members of Centre were published, the Centre hosted a major international conference in June and I built a new practice based PhD programme. I have a successful track record of winning research funding (listed below). My CV also illustrates a history of collaborative co-publication. Many of these publications have involved mentoring junior scholars, my research students or former arts practitioners or teachers who do not have confidence publishing academically. I featured on live to air radio a number of times, and The Times Higher Education Supplement published a review of my research.

I co-founded the new Goldsmiths Disability Research Centre. The Disability Research Centre (DRC) in 2015. The DRC is a specialist research grouping that promotes and conducts high quality interdisciplinary research and research-led teaching about disability in society. The Centre's activities enhance the College's commitment to interdisciplinary collaboration. I initiated the first *Practice as Research* Seminar at Tate Modern in conjunction with Goldsmiths.
